In the newsletter from the end of 2014 we wrote that 2,200 B of Joy participants were involved. As a result of the 2015 B of Joy lectures we inform you that there are now 4,600 people associated with our initiative. The only remaining question is: When? Gradually it has become clear that the real crisis is in our consciousness. Since autumn 2015 more and more Bail-free contracts have been signed. As expertly trained persons, it is not always that funny to provide the bigger pictures in this world on the basis of many indications.

It is very important to fully understand how the current banking system actually works. How it almost controls all facets of life, directly or indirectly. With a fair trade cooperative bank, managed by ourselves, we can free ourselves by becoming the owner of our bank accounts and of our lives. Unfortunately very few other options remain ...
